This covers legal liability for damages and legal costs arising out of Third Party loss, injury or damage, in connection with the activities described above and notified to Brit Syndicate within the period noted above. Cover includes public liability, professional indemnity, liability for damage to leased and rented premises, indemnity to principals and liability arising out of goods sold or supplied including refreshments. The cover is written on a claims made wording, which means that the cover will respond when the claim is made, not when the incident occurred.

All incidents that may give rise to a claim in the future should be notified to Citynet Insurance Brokers through Brit Syndicate (NRPT) at the time of incident.

- \* The ownership, possession or use of any mechanically propelled vehicle, aircraft, hovercraft or water-borne craft
- \* Product Guarantee or recall, repair or replacement
- \* In connection with damage to any data
- \* Medical malpractice
- \* Damage to own property
- \* Abuse in respect of the individual accused or alleged to have committed abuse or have permitted abuse
- \* Incidents prior to the retroactive date
- \* Incidents / claims known to you but not reported to Insurers.

Restricted cover applies in respect of legal actions brought in a court of Law within the USA or Canada
